

CANUCKS FANTASY HOCKEY GRAND PRIZE CONTEST
(the "Contest")

RULES & REGULATIONS

NO PURCHASE NECESSARY. CONTEST IS VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. SEE ELIGIBILITY SECTION BELOW FOR FURTHER DETAILS. TO COMPLETE YOUR ENTRY YOU MUST READ AND AGREE TO THE FOLLOWING TERMS. PARTICIPATION IN THIS CONTEST CONSTITUTES FULL AND UNCONDITIONAL AGREEMENT AND ACCEPTANCE OF THESE CONTEST RULES. ALL DOLLAR AMOUNTS ARE IN CANADIAN FUNDS (\$CDN) UNLESS OTHERWISE NOTED. THE SEARCH CONTEST IS CONDUCTED BY VANCOUVER CANUCKS LIMITED PARTNERSHIP ("VCLP")

- (1) THE CONTEST: The Canucks Fantasy Hockey participant with the highest points average at the end of the regular Vancouver Canucks hockey season will receive a team-signed Authentic jersey. Participants need to have played in at least 10 Canucks Fantasy Hockey rounds for their average to count.
- (2) CONTEST PERIOD: The Contest begins at 09:00AM Pacific Standard Time ("PST") on Saturday, November 15, 2008 and ends at 11:00PM PST on Saturday, April 11, 2009. (the "Search Period").

(3) ELIGIBILITY

Entrants are not eligible to participate in the Contest if they are:

- a. Owners, governors, officers, directors, partners, partnerships, principals, employees, agents, and representatives of VCLP, or its related entities, or
- b. A member of the household and/or immediate family of any of the above parties. For the purpose of the Search Rules, "immediate family" means husband, wife, spouse, mother, father, brother, sister, son and/or daughter, whether or not they reside in the same household.
- c. VCLP shall have the right at any time to require proof of identity and/or eligibility to participate in the Search. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to VCLP for the purpose of the Search must be truthful, complete, accurate and in no way misleading. VCLP reserve the right to disqualify any entry or entrant in its and their sole discretion, should any entry or entrant at any stage contain and/or supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

(4) HOW TO ENTER

You earn points in each Canucks Fantasy Hockey game by first selecting your "team" from members of the Vancouver Canucks roster. Canucks players earn points for you by scoring goals, getting assists, giving hits, etc. But you are limited in the number of players that you can choose by a salary cap. (5) REQUIREMENTS OF CONTEST WINNERS: Winners must comply with all contest rules as published. In the event of a tie for the Grand Prize, the judging panel will consider relevant factors. The potential Grand Prize winner (or parent/legal guardian if winner is a minor in his place of residence) will be required to sign and return an Affidavit of Eligibility, Liability and Publicity Release, where permitted, within one (1) day from the date of notification.

- b. agrees to be bound by the decisions of VCLP, which shall be final and binding in all respects;
- c. agrees to sign and return Grand Prize Winner Release, as applicable; and

d. grants to VCLP and/or its and their agents the unrestricted right for any purpose to produce, reproduce, publish, broadcast, communicate by telecommunication, exhibit, edit, distribute, adapt and otherwise use or re-use his/her Video or photograph Submission, without compensation, in any and all media now known or hereafter devised.
